## Re: Smoke-free Signage at Winterlude

Dear Mr. Mills and Councillor Holmes:

I am writing on behalf of the Ottawa Council on Smoking or Health (OCSH) to applaud the National Capital Commission (NCC) and the City of Ottawa for providing a smoke-free environment when viewing the magnificent Winterlude ice sculptures at Confederation Park.

The OCSH is a local volunteer organization established in 1978. Our goals are to: protect the public from second-hand smoke; prevent youth from starting to smoke; encourage smokers to quit; and advocate for better smoking cessation resources.

We are pleased that the NCC is expanding the scope of the City of Ottawa's *Smoke-Free Outdoor Bylaw* at Confederation Park and that the NCC and the City of Ottawa have posted smoke-free signage at venue gates.

We have received positive feedback from our members who have enjoyed Winterlude events during the day and at night without worrying about second-hand smoke exposure. Our members wish to thank the NCC for taking this important step in providing a healthy space for Ottawa residents, tourists, volunteers and workers at Confederation Park during Winterlude.

The health benefits of smoke-free living accumulate each year. This year, the U.S. Surgeon General's Report concluded that exposure to second-hand smoke is now considered a cause for strokes.<sup>1</sup> By promoting smoke-free Winterlude venues, the NCC and the City of Ottawa are protecting the public from exposure to the *69 class A carcinogens* found in second-hand smoke. An additional benefit is that youth now experience smoke-free events as part of a normal healthy environment.
